

## **Informing about the processing of personal data for visitors of events organized by SLLC “Liepāja Symphony Orchestra”**

The purpose of processing your personal data is photographing, making video or audio-visual recordings of events organized by SLLC “Liepāja Symphony Orchestra” to inform the public about events and promote attendance at SLLC “Liepāja Symphony Orchestra” concerts.

The legal basis for processing your personal data is pursuing of the controller's legitimate interests (Article 6, Paragraph 1, point (c) of the General Data Protection Regulation, the Law on Submissions). Taking into account that the concerts organized by the SLLC “Liepāja Symphony Orchestra” are public events, visitors should bear in mind that at public event venues photographs may be taken both by the event organizers and by the media.

Potential personal data recipients:

- SLLC “Liepāja Symphony Orchestra” specify the position that processes photographs (publishing photos and videos on SLLC “Liepāja Symphony Orchestra” social media, website, storage),
- Data processors of SLLC “Liepāja Symphony Orchestra” (for administration of information and communication technology resources, website hosting service providers),
- SLLC “Liepāja Symphony Orchestra” photo and video camera operator/s (involved in photography and video recording, photo and video processing),
- as well as any other person legally accessing the resources where photos and videos are published.

Photos and videos may be published on the SLLC “Liepāja Symphony Orchestra” website [www.lso.lv](http://www.lso.lv), on SLLC “Liepāja Symphony Orchestra” social media accounts, such as Facebook.com, Twitter.com and Instagram.com, where they will be stored for 1 year after publishing.

Your personal data may be stored for archival purposes for 5 years upon individual assessment, photos and video materials may be stored for a longer period of time to make history for the public.

Please note that you, as a data subject, have the right to:

request the controller to access the personal data processed by you as a data subject, request the correction or deletion of inaccurate personal data after submitting a valid reason for your request, in cases established by law, request restriction of processing of your personal data, as well as to refuse data processing.
